- 6. *Heng Community Fish Pond atan hian a tul dan angin MGNREGA Wages leh Material Component bakah Convergence hmangin fund dang remchang apiang hman theih a ni ang.***
- 7. *Success story tur hi mumal takin write-up leh Video te nen a siam zawn a nih ve leh Administrative Department-ah theuhluk tur a ni.***
- 8. *Heng Model Community Pond hi nakum ni 15<sup>th</sup> August, 2023 hma in a nih dan tur anga peih fel vek leh commission vek tur a ni.***
